

Letter from President

ear Mountains and Meadows Pickle Club members

We are currently working with The Club at Aspen Village to continue our successful partnership. We hope to begin play soon.

Beginning May 19th, we will have play at the Lutheran Church on two courts. We will play Tuesday and Thursday at 5:30 pm and Friday at 10:00 am. Watch your email for "pop-up" play – Spur of the moment play on days when the weather cooperates or we have time to put a game together.

The following guidelines will be followed:

- 1) The pickleballs are washed before you begin your game.
- 2) Every person on the court will have been through 14 days of isolation directly prior to coming out to play. This would assure they have not unknowingly picked up the virus anywhere. If they have been anywhere around people after completing the 14 days of isolation and prior to coming to play, they could potentially be carriers again.

- 3) Engage in physical distancing of at least 6 feet.
- 4) Practice good hand hygiene.
- 5) The courts to be played on have not had anyone carrying the virus playing on the courts in the last few days (supposedly the virus can live on the hard surface for quite a while). If everyone adheres to these guidelines, there is no danger of the ball picking up the virus while you are playing.
- 6) Players must schedule their play so only two courts are used with 4 players on each court. Total of 8 players on the courts. This follows the Stage 2 Idaho Rebounds guidelines.
- 7) Players are asked to bring a patio chair and relax by their vehicles while waiting to play.
- 8) A release from responsibility signature will be required each day of play.
- 9) A \$5.00 donation is suggested for the church.

Due to the delay in opening the Aspen Courts, play will temporarily take place at the Lutheran Church parking lot.

The plan is to play on two courts - 8 players only at one time (2 courts /4 players each). Those waiting to play will remain in their vehicles or safely distanced six feet from others waiting to play.

Pickleballs will be sterilized after each round and nets will be wiped down. We encourage all players to use hand sanitizers before and during play.

If you have been out of the area we encourage you to self quarantine for two weeks before joining us on the court.

If you are not feeling well or are "at risk" - please stay home.

Suggested Donation: \$5 drop-in play or Pickleball Pass - \$25 (unlimited play until Aspen Courts open).



Group play, with appropriate social distancing, sanitizing of balls etc., will begin June 1st - Monday & Friday

10am/12noon and Wednesday evenings 6.00/8.00pm on upper dual purpose court (4 pickleball courts available).

Players are requested to check-in at the ProShop. Play Fee: Season Pass \$40 couple / \$25 single or \$5 per session



The Club at Aspen Village management have made the decision to postpone opening the indoor gym and all outdoor facilities until some time later in the month. The Pickleball courts are under the directive of the Aspen Village management. A meeting of the HOA Board will take place on June 20th to discuss opening of The Club.

Paul Christensen has put together safety protocol to meet current Idaho State guidelines for when the Aspen courts open.
